Introduction

Literary and Historical Society

The Literary and Historical Society was founded in 1855-1856 by Cardinal Henry Newman, Rector of the Catholic University of Ireland, 86 St Stephen's Green, Dublin. The Society is first called the 'Historical, Literary and Aesthetical Society' with a 'President' at its head from 1857. In 1862-1863 and 1863-1864 newspaper reports refer to the 'Historical and Literary Society connected with St.Patrick's College' and the 'President' has become the 'Auditor' (St Patrick's College was another of Newman's foundations in 86 St Stephen's Green). Later, in January 1865, reports refer to the 'opening meeting of the revived Literary and Aesthetical Society'. The 'Aesthetical' part of the title was dropped around 1869.

In early years papers and verse compositions were read alternately at meetings by students and professors. (Papers were alternated with debates into the early years of the twentieth century). The first formal debate was held in 1858 on the motion 'Which was the greater man, Julius Caesar or Napoleon?'. Topics were often tame because of a rule forbidding discussion of British politics. From 1886 subjects for debate were submitted to the President of the College in a further effort to control discussions on the sensitive issues of the day. Inaugural meetings and the annual awarding of medals for oratory to individual members of the Society date from the foundation of the Society. The invitation to public personages to address the Society was emphasised in order to provide publicity for the University in seeking a charter, which seemed imminent in the late 1860s. Guests addressed the Society on formal occasions from the late 1860s and included Isaac Butt who gave a lecture on 'The Early History of Venice' in 1869.

Through the Universities Education (Ireland) Act 1879, the Royal University was set up as an examining body. Preparation of Catholic students for these examinations was carried out by the Society of Jesus in St Patrick's House of the Catholic University which was then called University College Dublin or the Jesuit University College. The Society ceases to function from December 1880 and emerges in November 1882 as the 'Union Literary Society' (until 1883) with an Auditor, nine committee members and an annual subscription of five schillings (SOC2/1). From 1882 until the establishment of the National University of Ireland c.1908, Jesuit teachers were to hold office in the Literary and Historical Society with Father Tom Finlay becoming Auditor in 1883-1884 due to the small number of students in the Society.

After the Irish Universities Act 1908, the Jesuit University College joined with existing colleges in Cork and Galway under the NUI. Subsequent growth in numbers of students resulted in increasing pressure to permit female students to become members of the Society (SOC2/3). Inter varsity debates became more frequent in these years developing into standard annual competition debates such as the Observer Mace and USI/Irish Times Trophy debating tournaments. Committee members consisting of a Record Secretary, Correspondence Secretary, Treasurer and at least four ordinary committee members were elected until 1932 and thereafter nominated by the incoming Auditor. Auditorial elections usually occurred at the end of each session and in order to be eligible as a candidate members were obliged to have spoken in debate at least once (from 1933). The number of speeches required has varied over the years. Membership cards were introduced in 1950-1951 by Auditor, Richard Ryan.

In 1944-1945 a fund was established to subsidise Centenary celebrations of the Society with Arthur Cox and James Meenan (ex-Auditors) appointed as trustees (see SOC2/29 and SOC2/31). In 1951 a committee was appointed to collect and house the records of the Society and to examine the project of a Centenary history (SOC2/35, SOC2/38, SOC2/194). James Meenan became the General Editor of the Centenary history published in 1956 (SOC2/194, SOC2/195, SOC2/196).

Many members of the Literary and Historical Society have, in subsequent years, played important roles in public, professional, ecclesiastical, business and judicial life in Ireland. James Joyce (Writer) and Hugh Kennedy (Attorney General and Chief Justice) competed in the auditorial elections for 1900-1901, for example, with Kennedy winning the election (SOC2/2). The records of the Society provide ancillary biographical information of the College life of many individuals while debate topics and resolutions reflect the contemporary interests and opinions of the student population, over the years. The Literary and Historical Society is significant in the context of the development of University College Dublin since it is one of the sole survivors of Newman's Catholic University into the present College.

Records of the Literary and Historical Society

The description of approximately half the documents in this collection, and this introduction, is based on a list produced in January of 1990*. While these descriptions and the introduction have been edited, the initial arrangement of the collection has been maintained and elaborated to accommodate material obtained by the Archives Department since this initial list was completed (extra sessional correspondence files,

photographs, posters, a videocassette of the Irish Times Final in 1984, and material relating to the World Debating Championships in 1987).

This collection starts with the first surviving minute book to date (SOC2/1) and contains the records of the Society up to 1992. There are some gaps due to loss or accident (see SOC2/7) or because material has yet to be deposited.

The collection has been arranged in six broad categories: Organisation and Administration, Photographs, Centenary History Committee, Posters, Video Cassette of the Irish Times final 1984 and World Debating Championships 1987.

A ORGANISATION AND ADMINISTRATION, 1882-1992

i Minutes of Meetings, 1882-1987

1. November 1882-April 1883; November 1885-December 1890; November 1897-January 1898; March 1906 Minute book of the Union Literary Society containing the handwritten minutes of general meetings and committee meetings of the Literary and Historical

Society. Committee meetings (1885-1890; 1897-1898; one meeting in 1906 towards the back of the volume) are generally held weekly. The minutes give details of attendance and deal with general administration of the Society including: amending the rules of the Society (1897-1898, p.95), admission of members, organising inaugural meetings, and deciding motions for debates at general meetings on subjects such as the Irish University Question (27 November 1885, p.30) or Home Rule (7 May 1886, p.43). Fewer meetings are recorded for 1888-1889, only two in 1890 and one in 1906.

General meetings (1882-1883 of the Union Literary Society; one meeting in 1906 towards the back of the volume) are usually held fortnightly. The minutes record the name of the Chairman, the reading and signing of the previous minutes, the motion for public debate such as 'That capital punishment should be abolished' (31 January 1883, p.13) and the names of speakers. Ordinary business such as nominations for membership, deciding the structure of the committee, amount of annual subscription, and system of awarding medals for oratory (January 1883, p.11), or deciding the topic of the next meeting (28 February 1883, p.17) occurs at the end of the meeting when 'strangers or non-members' have withdrawn.

The minutes are entered in chronological order. The minutes are generally signed by the Auditor or by the Chairman. A list of members is included at the back of the volume (no date is given). The volume is paginated to page 100.

2. February 1884-March 1891; November 1897-June 1907 Minute book of the Literary and Historical Society containing the

handwritten minutes of committee meetings, general meetings, extraordinary general meetings and inaugural meetings. Committee meetings are usually held within a fortnight of each other. The minutes give details of attendance and deal with general administration of the Society including: election of officers to the committee, establishing rules and functioning of the Society (for example regulations for future general meetings of the Society, 17 November 1899, pp.189-190), organising the sessional programmes of events including dates and subjects of general meetings such as a debate on the Intermediate Education System (3 March 1884, p.5), and arranging debates with other societies such as the Solicitor's Apprentices' Debating Society (24 November 1900, p.212).

General meetings are usually held weekly. The minutes record the name of the Chairman, the reading and signing of the previous minutes, the motion for public debate and the names of speakers. Other business recorded includes election of the committee and election of members to the Society.

The minutes of extraordinary general meetings name the Chairman/speakers and state the purpose of the meeting. The meetings are generally held to consider changes to the rules of the Society (18 December 1903, p.274) or resolutions

on procedure at general meetings such as having the Auditor or gentlemen who were not student members of the Society act as Chairman at general meetings (13 November 1885, p.61).

Inaugural meetings usually take place in November. The minutes generally record the title of the Auditor's address, the names of speakers and sometimes list the winners of annual medals awarded for oratory and the auditorial election poll. The minutes often record a resolution passed at the meeting to have the inaugural address printed and distributed at the expense of the Society.

The minutes are entered in chronological order, apart from committee meetings in 1898 which appear after page 346. The minutes are generally signed by the Auditor or by another member of the committee. The volume is paginated to page 346.

3. May 1906-November 1916

Minute book of the Literary and Historical

Society containing the handwritten minutes of committee meetings, general meetings, extraordinary general meetings and inaugural meetings. Committee meetings are held frequently (up to twice weekly). The minutes give details of attendance and deal with general administration of the Society including: establishing rules of the Society and procedure at general meetings (reference to use of Palgrave's Chairman's handbook, 12 March 1907, p.25 and reference to enrollment of lady members, 30 January 1908, p.57), co-opting committee members, appointing subcommittees such as that arranging the inaugural meeting (February 1908, report p.60) and commissions such as that investigating inaugural expenses (February 1908, report p.64), organising sessional programmes of events including deciding topic of debates or papers read at general meetings and organising debates with other debating societies such as the Solicitors' Apprentices and Queen's University Belfast, invitation of guest speakers and chairmen to debates, and controlling expenditure.

General meetings are usually held weekly. Private business occurs at the beginning of the meeting. The minutes record the reading and signing of the previous minutes, question time and motions on notice. The election of committee members may also be recorded. Private business is followed by a record of the public debate. The minutes record the name of the Chairman and the motion for public debate such as 'That the sympathetic strike is unsound in principle' (15 November 1913, p.256) or the title of papers read before the Society such as one on Australian poetry (26 January 1907, p.10). The names of speakers are recorded and also the marks that they are awarded. Marks awarded count towards annual medals given for oratory. On occasion the names of good maiden or first time speakers are noted (23 February 1907, p.15).

The minutes of extraordinary general meetings name the Chairman/speakers and state the purpose of the meeting. The meetings are generally held to consider changes to the rules of the Society (16 March 1907, p.27). Meetings are also held to declare the result of auditorial elections, to consider the reports of outgoing officers, and to announce the winners of annual medals awarded for oratory (17 May 1913, p.249).

Inaugural meetings usually take place in November. The minutes generally record the title of the Auditor's address, the names of speakers and sometimes list the winners of annual medals awarded for oratory (7 November 1913, p.253).

The minutes are entered in chronological order. The May to December 1906 minutes are re-entered after March 1907 on pages 19-21 'necessitated by the loss of the Minute book previously in use'. The minutes are generally signed by the Chairman, Auditor or by another member of the committee. There is an

alphabetical index to topics at the beginning of the volume. The volume is paginated to page 374.

4. May 1923-March [1931]

Minute book of the Literary and Historical

Society containing the handwritten minutes of committee meetings. The meetings are held periodically throughout the session. The minutes give details of attendance and deal with general administration of the Society including: appointment of officers to the committee; financial administration; organising sessional programmes of events such as deciding dates and motions for debate at general meetings; arranging inaugural meetings; arranging debates with other debating societies such as the Literary and Scientific Society of Queen's University Belfast, and societies from Trinity College Dublin, University College Cork and University College Galway (14 February 1925); and organising a dance (24 October 1923).

The minutes are entered in chronological order. The minutes are generally signed by the Auditor. From 1925 to 1931 a list of committee members is recorded at the beginning of the minutes for each session.

5. June 1936-February 1945

Minute book of the Literary and Historical

Society containing the handwritten minutes of general meetings, extraordinary general meetings, inaugural meetings and annual general meetings.

General meetings are held weekly. Private business occurs at the beginning of the meeting. The minutes record the reading and signing of the previous minutes, the reading of correspondence, question time, and motions on notice (usually of a humorous nature). Private business is followed by a record of the public debate such as 'That this House refuses to take up arms for a United Ireland' (3 May 1941) or 'That Eire will perish if she forgets her traditional policy of the gun' (21 November 1942). The names of speakers are recorded and also the marks that they are awarded. Marks awarded count towards annual medals given for oratory. Minutes are sometimes entered as dramatic dialogue (such as 21 November 1942), in verse (such as 25 November 1939) and partially in Irish (such as 1 May 1937).

The minutes of extraordinary general meetings name the Chairman/speakers and state the purpose of the meeting. The meetings are generally held to consider changes to rules of the Society.

Inaugural meetings usually take place in November or December. The minutes generally record the title of the Auditor's address, the names of speakers and sometimes list the winners of annual medals awarded for oratory.

Annual general meetings usually occur in May. The minutes on occasion, record the reports of the outgoing officers (Auditor, Treasurer, Secretary) as well as the results of auditorial elections and the winners of annual medals awarded for oratory.

The minutes are entered in chronological order. The minutes of the May 1944 annual general meeting appear at the back of the volume. The minutes are generally signed by the Auditor or another officer of the Society. A list of officers and committee members is usually recorded at the beginning of the minutes for each session. The back of the volume contains a roll of members from 1939-1945 consisting of the members signature and their address.

6. March 1945-1956

Minute book of the Literary and Historical

Society containing the handwritten minutes of general meetings, extraordinary general meetings, inaugural meetings and annual general meetings.

General meetings are held weekly. Private business occurs at the beginning of the meeting. The minutes record the reading and signing of the previous minutes, the reading of correspondence, question time and motions on notice (usually of a humorous nature). Private business is followed by a record of the public debate. The minutes record the name of the Chairman and the motion for public debate such as 'That the present regime in Spain was born and continues to exist in crime' (1 December 1945). The names of speakers are recorded and also the marks that they are awarded. Marks awarded count towards annual medals given for oratory. Minutes are sometimes entered as dramatic dialogue (such as 24 April 1948).

The minutes of extraordinary general meetings name the Chairman/speakers and state the purpose of the meeting. The meetings are generally held to consider changes to rules of the Society. Topics for consideration include the election of a Vice-President of the Society, James Dillon, Minister for Agriculture (21 May 1949).

Inaugural meetings usually take place in April or May. The minutes generally record the title of the Auditor's address, the names of speakers and sometimes list the winners of annual medals awarded for oratory.

Annual general meetings usually occur in May. The minutes, on occasion, record the reports of the outgoing officers (Auditor, Treasurer, Secretary) as well as the result of auditorial elections and the winners of annual medals awarded for oratory.

The minutes are entered in chronological order. The minutes are generally signed by the Auditor. A list of officers and committee members is usually recorded at the beginning of the minutes for each session. The volume contains a roll of members from 1948-1949 to 1951-1952 consisting of the members signature and their address. Included at the back of the volume are a list of Auditors from 1906 to 1956 and a copy of the amended constitution of the Literary and Historical Society (1948-1949).

7. [May] 1953-1980

Minute book of the Literary and Historical

Society containing the handwritten minutes of general meetings, extraordinary general meetings, inaugural meetings and annual general meetings.

General meetings are held weekly. Private business occurs at the beginning of the meeting. The minutes record the reading and signing of the previous minutes, the reading of correspondence, question time and motions on notice (usually of a humorous nature). Private business is followed by a record of of the public debate. The minutes record the name of the Chairman and the motion for public debate such as 'That the theatre has ceased to fulfil a cultural need in Ireland' (6 December 1958). The names of speakers are recorded and also the marks that they are awarded. Marks awarded count towards annual medals given for oratory. Minutes are often entered in verse (such as in 1954 and 1960). Guest speakers recorded at a debate on Irish newspapers on 25 March 1954 include Patrick Kavanagh (Poet) and Brian O'Nolan (Myles na Gopaleen, Writer). The minutes also record the holding of the first annual Scots-Irish debate for the Irish Times Trophy, held on 28 April 1962.

The minutes of extraordinary general meetings name the Chairman/speakers and state the purpose of the meeting. The meetings are generally held to consider changes to the rules of the Society. Topics for consideration include a

nomination for vice-presidency of the Society (5 November 1960) and revision of the constitution (1 February 1963).

Inaugural meetings usually take place in November or in February. The minutes generally record the title of the Auditor's address, the names of speakers and on occasion list the winners of annual medals awarded for oratory as well as giving a general description of proceedings.

Annual general meetings usually occur in May. The minutes, on occasion, record the reports of the outgoing officers (Auditor, Treasurer, Secretary) as well as the result of auditorial elections and the winners of annual medals awarded for oratory.

The minutes are entered in chronological order. Minutes from October 1953 to May 1954 are rewritten due to the loss of a previous minute book 'occasioned by the irresponsibility of a party of engineers who having purloined the Minute Book accidently dropped it into the Liffey at O'Connell Bridge' (see front of volume). The minutes are generally signed by the Auditor. A list of officers and committee members is usually recorded at the beginning of the minutes for each session. A list of Auditors from 1856-1857 to 1979-1980 appears at the front of the volume.

8. October 1965-May 1969

Minute book of the Literary and Historical

Society containing the handwritten minutes of general meetings, extraordinary general meetings, inaugural meetings and annual general meetings.

General meetings are held weekly. Private business occurs at the beginning of the meeting. The minutes record the reading and signing of the previous minutes, the reading of correspondence, question time and motions on notice (usually of a humorous nature). Private business is followed by a record of the public debate. The minutes record the name of the Chairman and the motion for public debate such as 'That there is nothing for which we would die' (intervarsity debate, 20 November 1965, p.34) or 'That censorship is the cause of Irish neurosis' (26 November 1966, p.141). The names of speakers are recorded and also the marks that they are awarded. Marks awarded count towards annual medals given for oratory. Minutes are sometimes entered as dramatic dialogue (11 December 1965, p.45) and in verse (30 October 1965, p.12).

The minutes of extraordinary general meetings name the Chairman/speakers and state the purpose of the meeting. The meetings are generally held to consider changes to the rules of the Society.

Inaugural meetings usually take place in November or December. The minutes generally record the title of the Auditor's address, the names of speakers and sometimes list the winners of annual medals awarded for oratory.

Annual general meetings usually take place in May. The minutes, on occasion, record the reports of the outgoing officers (Auditor, Treasurer, Secretary) as well as the result of auditorial elections and the winners of annual medals awarded for oratory.

The minutes are entered in chronological order. The minutes are generally signed by the Auditor and/or another officer of the Society. A list of officers and committee members is recorded at the beginning of the minutes for each session. The volume is paginated to page 546.

9. May 1969-February 1978

Minute book of the Literary and Historical

Society containing the handwritten minutes of general meetings, extraordinary general meetings, inaugural meetings and annual general meetings.

General meetings are held weekly. Private business occurs at the beginning of the meeting. The minutes record the reading and signing of the previous minutes, the reading of correspondence, question time and motions on notice (usually of a humorous nature). Private business is followed by a record of the public debate. The minutes record the name of the Chairman and the motion for public debate such as 'That the IRA deserves to be condemned' (30 October 1971) or 'That Newman's University has always overworked and undereducated its student gentlemen' (March 1976). The names of speakers are recorded and also the marks that they are awarded. Marks awarded count towards annual medals given for oratory. Minutes are sometimes entered as dramatic dialogue (2 November 1973) and in verse (27 November 1973).

The minutes of extraordinary general meetings name the Chairman/speakers and state the purpose of the meeting. The meetings are generally held to consider changes to the rules of the Society.

Inaugural meetings usually take place in November, December or January. The minutes generally record the title of the Auditor's address, the names of speakers and sometimes list the winners of annual medals awarded for oratory. Annual general meetings usually take place in May. The minutes, on occasion, record the reports of the outgoing officers (Auditor, Treasurer, Secretary) as well as the result of auditorial elections and the winners of annual medals awarded for oratory.

The minutes for meetings are, as Cormac Lucey states, a humorous "revue" style as performed for the audience. These comic sketches are generally political in nature. The records of meetings, according to Lucey, are a straight factual account of the meeting. The records note for example the motion for debate such as 'That Christianity represents the World's only hope' (12 November 1982, p.73), names the principal speakers including guest speakers and marks awarded to Society speakers.

The minute book also contains press cuttings, photographs taken at debates of the audience and speakers, a letter and other items relating to the Literary and Historical Society. Included are press cuttings from the Evening Herald, UCD News, Western People, Sunday Times, Irish Times, Evening Press and Irish Press relating to the Literary and Historical Society and the auditorship of Cormac Lucey. Included is Cormac Lucey's membership card for the Literary and Historical Society, 127th session, 1982-1982 (p.20). Included is a cardboard full-length portrait of the Auditor, Cormac Lucey, used in a comic performance at a general meeting (p.43). Included is a typescript letter from Sir John Biggs-Davison MP, House of commons, London to Cormac Lucey apologising for his inability to attend a debate due to a request

An extraordinary general meeting was held on 26 January 1984 for the purpose of hosting the Irish Times debating final. The minutes record the name of the Chairman, the motion for debate - 'That Ireland's recent past gives little hope for the future'-, the names of speakers and an account of their respective speeches.

The inaugural meeting took place on 25 November 1984. The minutes list the winners of annual medals awarded for oratory, record the title of the Auditor's, Shane Murphy's, address - 'Crime and Society' - and the names of speakers to the paper as well as giving a general description of proceedings.

The annual general meeting took place on 4 May 1984. The minutes record the reading of the Treasurer's and the Secretary's report and record the Auditor's report and the report of the Returning Officer. The result of auditorial elections and the winners of annual medals given for oratory are also recorded.

The minutes are entered in chronological order. The minutes are signed by the Auditor, Shane Murphy. A list of officers and committee members is recorded at the beginning of the minutes. A programme for the Auditor's dinner held at Newman House, 86 St. Stephen's Green, Dublin on 9 March 1984 is pasted into the front of the volume. Occuring after the end of the minutes is a list of guest speakers for the 129th session 1983-1984, a list of the Society's achievements during the session (including the winning of the Observer Mace), a printed poem entitled 'Morte d'Auditor' and a notice for the final of the Observer Mace Debating Competition. Private business is generally followed by a record of the public debate. The minutes record the motion for public debate such as 'That Justice is not seen as well as done' (25 January 1985). The names of speakers are recorded and also the marks that they are awarded. Marks awarded count towards annual medals for oratory.

The minutes of extraordinary general meetings name the speakers and state the purpose of the meeting. The meetings are generally held to consider changes to rules of the society.

The meeting of the court of the Returning Officer and the meeting of the acting Legal Assessors deal with an appeal that had been lodged regarding the validity of some 940 names on the register of voters.

The minutes of the annual general meeting, held in April, record the reports of the outgoing officers (Auditor, Treasurer, Secretary) as well as the result of the auditorial elections and the winners of annual medals awarded for oratory.

The minutes are entered in chronological order. The minutes are generally signed by the Auditor.

My very dear friend and mouthpiece, Mr.McBryan, has my instructions to return my skull to its accustomed place upon the Table, unless circumstances point to a re-opening of the matter by the Society'.

(This letter was raised at at least two general meetings of the Literary and Historical Society, on 11 December 1943 and on 30 April 1949. See SOC 2/5 and SOC 2/6).
