Please see below details of curriculum edits closing on Friday, 6 September.

Amendments to Major Structures and Careers & Skills Statements

The [Structure Change Request Form](#) that has been used to record final changes to majors will close on Friday, 6 September. From Monday, 9 September changes to structures will require approval as a programme change by your Governing Board (via a [PDARF16](#) form). Requests to add Careers & Skills details should be returned on a signed [PDARF7](#) form.

Module Descriptor Edits Closing Friday, 6 September

Edits to module descriptors on the [My Modules](#) menu on the Curriculum Management System (CMS) will close on **Friday, 6 September**. The [Module Descriptor Change Request Form](#) that has been used to record final amendments to Requirements/Prior Learning, Student Effort Hours, Credit Split by Trimester, Module Status and Trimester for Delivery will also close on the same day.

Finalising Module Descriptors: Urgent Action Required by Friday, 6 September

22% of modules in the University have no assessment strategy recorded for 2024/25. This creates a poor experience for students who are actively making module selections on the basis of incomplete information, and will have serious operational consequences for exam scheduling and grade entry once term commences.

Urgent action is required from all Module Coordinators to ensure that descriptors are completed prior to 6 September. The [Modules Missing Data](#) report on InfoHub shows modules where assessment or other mandatory details have not been recorded, and also where there are anomalies in module information.

A communication about the module descriptor closing has been circulated to Module Coordinators and is included below for reference. Module Coordinators who have modules with no assessment strategy have also

been emailed directly with a request to take urgent action to address this.

Module Descriptor Changes from Monday, 9 September

From Monday, 9 September, amendments to modules commencing in the Autumn trimester (including the addition of assessment strategies) will require an [exemption](#) on the basis of exceptional circumstances approved by the Head of School and College VP for Teaching & Learning.
