Please see below reminders about Spring/Summer module descriptor edits closing on the Curriculum Management System.

Schools and Colleges: Edits to Spring / Summer Module Places Closing 23 December 2024

- The <u>Module List Management Update Module Places</u> menu will close for edits to places on modules commencing in the Spring and Summer trimesters on **Monday**, 23 December.
- After this date, requests to change module places should be directed to systems.data@ucd.ie.
- Module Coordinator changes can be made year-round on <u>Update Module Details</u> by colleagues with School- or College-level access to the CMS.

Module Coordinators: Edits to Spring / Summer Module Descriptors Closing 3 January 2025

- The My Modules menu will close for changes to modules commencing in the Spring and Summer trimesters on **Friday, 3 January**.
- Spring or Summer trimester modules that don't yet have an assessment strategy recorded must be addressed as a priority.
- After module edits close, amendments to modules on offer in Spring must be requested and approved as an <u>exemption</u> on the basis of exceptional circumstances.

• There will be a final opportunity to amend modules commencing in Summer trimester 2024/25 from 22 April to 6 May 2025. See the <u>Module Descriptor Edit</u> <u>Timelines 2024/25</u> document for further details.
