- Programme Outcomes and Vision & Value Statements on the [Curriculum Review & Enhancement](#) menu (Programme Directors only)

Reviewing Major Structure Edits

The reports and checklist below will assist in a final review of September-intake major structures ahead of 15 May:

Module Descriptor Edits & Assessment Strategies

- Amendments to Requirements/Prior Learning and Module Places (via the module descriptor) for 2024/25 will close on **Wednesday, 15 May**. Amendments to module places can still be made by staff and faculty with School/College-level access via the [Update Module Places](#) menu until 26 July.
- All other sections of the descriptor will remain open for changes as outlined on the [Module Descriptor Edit Timelines 2024/25](#).

- Please note in particular the requirement for Module Coordinators to update the assessment strategies of all modules according to the new component types and timings implemented for 2024/25, and the impending publication of curriculum information for the upcoming Academic Year in early June. As students are heavily reliant on this information captured on the descriptor for planning their module selections, it is critical that assessment information is populated to aid in their registration planning.
- The new [Assessment Workload Report](#) provides Schools and Colleges with an overview of assessment strategies recorded to date.
- Module Coordinators have also been advised of this information and the communication is appended to the end of this mail.

Please see below updates relating to module descriptor edits for 2024/25.

Requirements/Prior Learning and Module Places Edits Closing 15 May

The Requirements/Prior Learning and Module Places sections of the module descriptor will close for edits to 2024/25 information on **Wednesday, 15 May**. Please ensure that you have reviewed and updated these details on the [My Modules](#) menu of the [Curriculum Management System](#) (CMS) in advance of this date. All other sections of the descriptor will remain open for edits as per the published [Module Descriptor Edit Timelines 2024/25](#). Your School Administrator will be able to amend module places on your behalf up until 26 July. An update on arrangements for final Requirements/Prior Learning changes through the summer will be circulated after 15 May.

Assessment Strategies 2024/25

As part of changes to the CMS for 2024/25, an updated set of assessment strategies and timings has been made available on the module descriptor in order to:

- Better reflect current and best assessment practice
- Give School/College teams a better overview of how and when assessment is taking place
- Provide greater clarity and transparency for students, and allow for more informed decisions when selecting modules

As part of the implementation of these changes, UPB mandated that assessment details for 2024/25 should be removed so that colleagues would engage with the updated list of assessment types and timings as part of the regular cycle of edits to module descriptors.

Assessment Strategies: Key Actions Required

The timeline for the publication of 2024/25 curriculum information to students in early June is approaching. As students rely heavily on information captured on the descriptor for planning their module selections for the upcoming Academic Year, please ensure that assessment information is populated to aid in their registration planning.
