### Position Summary:

UCD Veterinary Hospital (UCDVH) is seeking to appoint a career (core) veterinary nurse to support the hospital dispensary and provide a high standard of organisation and leadership to this unit. Candidates must hold a Veterinary Nursing Qualification registerable with the Veterinary Council of Ireland.

Successful applicants will be placed on a panel to fill current and future temporary vacancies for a period of up to 12 months after the interviews are held.

### Principal Duties and Responsibilities:

#### 1. Nursing duties

- Provide support and advise on drugs and consumables to multiple disciplines
- Participate in nurse led services
- Preparation and dispensing of medications (under direction) as prescribed by a veterinary practitioner
- Nutritional advice (life stage and clinical diets) to students, staff and the public
- Care of equipment
- Handling scheduled drugs and maintaining controlled drugs register(s)
- Maintain a high standard of hygiene, cleanliness and organisation with emphasis on infection control for patients, staff, students and visitors to UCDVH

#### 2. Administration duties

- Stock control of drugs and consumables
- Use of e-procurement and e-Financials
- Update patient records using a dedicated patient management system
- Management of drug licences and MDA forms
- Sourcing drugs/consumables
- Facilitate effective communication between discipline teams
- Participate in creating and implementing local protocols
- Ensure infection control policies are adhered to at all times
- Ensure Health & Safety policies are adhered to at all times

#### 3. Teaching & training

- Supervision and training of veterinary medicine and nursing students
- Supervision and training of junior (rotating) nurses
- Demonstration of practical nursing skills
- Instruction in nursing care
- Instruction in the use of hospital equipment
- Assessment of veterinary medicine and nursing students
- Delivery of in-house teaching and CPD
- Participation in UCDVH annual conference

**Particular to this position:**

You will be required to work 36.5 hours per week over 5 days during the week between Monday and Sunday. Weekend and weekday out-of-hours working may be required on a rota basis. Start and finish times will vary depending on the needs of the hospital. The actual allocation of these hours of work will be arranged with your line manager.
